- Full-Time \$14,500 + \$1000 Mandatory Scholarship Fund = \$15,500
- 3 Day Week \$10,358 + \$1000 Mandatory Scholarship Fund= \$11,358
- 2 Day Week \$7,733 + \$1000 Mandatory Scholarship Fund= \$8,733

Enrollment is for the academic year that begins in September 2012 and ends in June 2013. Tuition payments must begin on April 1, 2012. If a student is accepted and enrolls after April 1, upon enrollment parents must remit all tuition payments missed between April 1, 2012 and the enrollment date.

If a child is withdrawn between April 1st and the first day of school, all tuition and fees paid up to that point are non-refundable. If a child is withdrawn after the school year begins, the parent/guardian is responsible for the full year's tuition.
